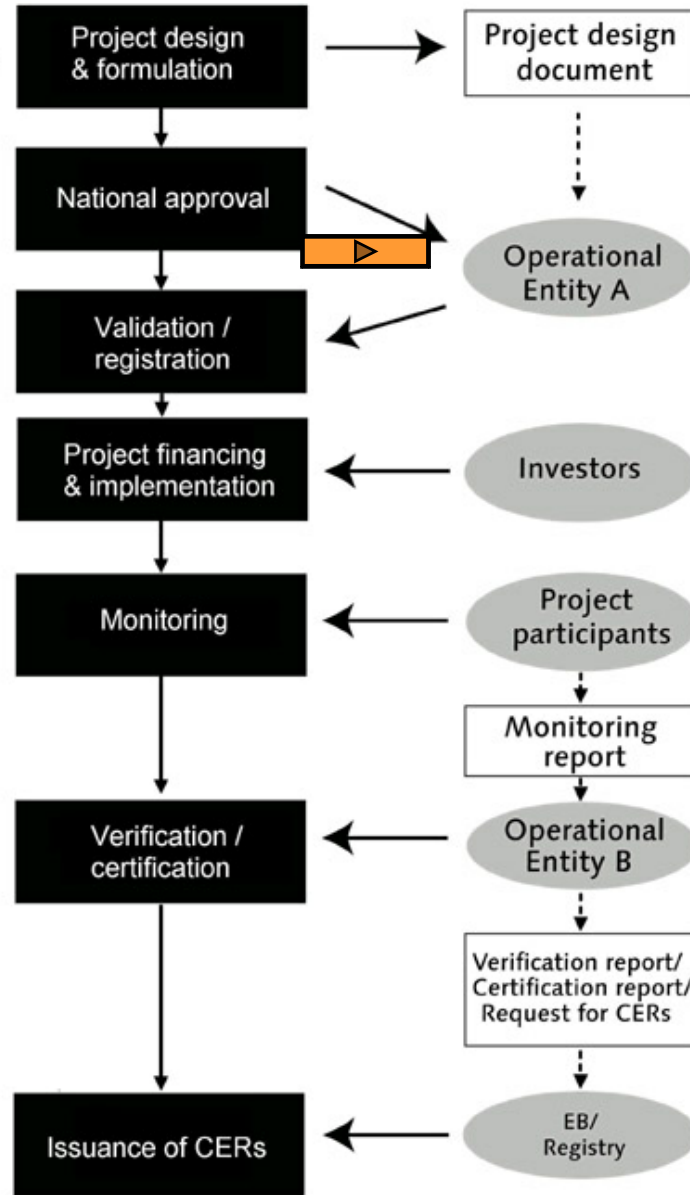

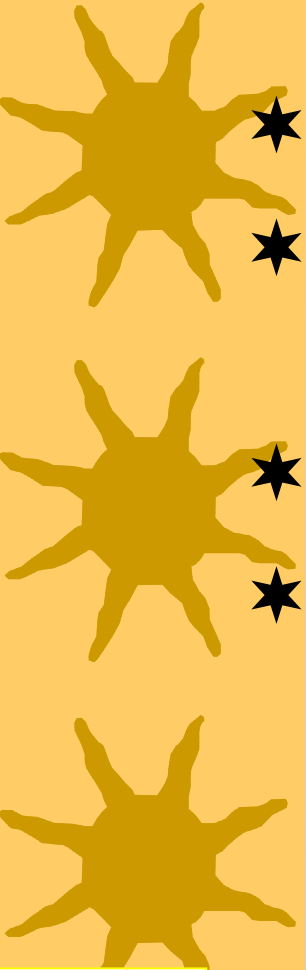

Project Design Document

- ★ The first Step for any CDM project
- ★ Should be prepared under the responsibility of the Project Participants
- ★ Should receive National approval 
- ★ The DNA should provide assistance and guidance for PDD development





Project Design Document

- ★ PDD preparation: to be funded by the project participants:
- ★ Part of the Transaction costs for CDM projects:
 - Preparation and Review steps of the PDD: US\$40,000
 - Baseline Study: US\$20,000-30,000
 - Monitoring Plan: US\$10,000-20,000



Project Design Document

- ★ PDD preparation costs: can be significantly reduced:
 - Project ideas are sometimes already developed
 - National expertise can be put up front of the process in the countries (channeling expertise to the CDM, capacity development, etc.)
 - Develop Generic/standardized Baselines
 - We can capitalize experience from the existing PDD





Project Design Document

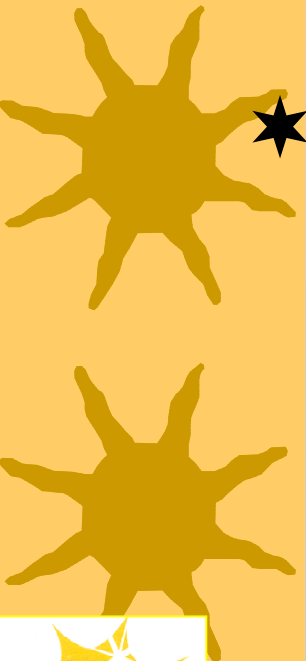
- ★ Special arrangements can be made to fund PDD preparation: Options →
 - Capacity development projects (UNDP, UNEP, World Bank, etc.) → e.g. UNDP in Morocco
 - Special arrangement between the CERs seller and buyer
 - DNA should have a yearly budget allocation to assist in preparing PDD
 - Etc.

- ★ Should follow a pre-defined format (posted at the UNFCCC/CDM Website)
